 2. The post reservation for all categories shall be as per the existing Government notification.
 3. Candidates applying for all the post categories should be given option of posts in order preference i.e 1st option _____ 2nd option _____ 3rd option _____ 4th Option.
 4. Candidates should furnish recent passport photos/Xerox copies of educational certificates/ documents, self attested along with the application:
 - a. Academic certificates.
 - b. Indigenous certificate.
 - c. Birth certificate.
 - d. Backward certificate.
 - e. Tribe certificate.
 - f. Unemployment certificate.
 - g. 3 (three) recent passport.
- The application with required certificate / documents should be submitted to Police Headquarter, Nagaland, Kohima during office hours. Application will be summarily rejected if any of the above certificates/ documents is incomplete/ tampered or forge. Serving Government employees applying for the post should submit NOC issued by concern HOD.
5. Candidates for shortlisted on various posts for viva voice are required to produce original documents/ certificates.
 6. **Education qualification:**
 - a. Candidates for the post of UBSI (GD)/ ABSI (GD)/ S.I (NPTO operational) must be a graduate in Arts/ Science/ Technical or equivalent of recognized universities/ institutions.
 - b. Candidates for the post of ASI (GD) must be a minimum CI-XII passed or equivalent degree/diploma of recognised university / institutions.


